- II.** Call to Order – Mark called to order the August 18, 2021 meeting of the Kenton County Parks & Recreation Commission.
- III.** Meeting Minutes: 5/12/2021 (BH, GS) Approved.
- IV.** 2021 Recreation Commission Appointments
  - a) Rhonda shared that Kathleen Carnes, Adam Davey, Brian Halloran and Mark Reitzes have been re-appointed through February 1, 2024.
- V.** New Kenton County Park Master Plan Update
  - a) Rhonda shared the Second Public Meeting Presentation from Human Nature that was hosted on August 4th. Rhonda shared the three concepts that were presented. The Commission discussed each concept, potential amenities and the process for moving forward with the master plan.
  - b) It was suggested to have a site visit or a meeting before the final plans.
- VI.** Park Projects Updates
  - a) Rhonda shared some pictures of the parks projects being completed.
    - a) Completed: Doe Run Lake Bridges and Trails, Mills volleyball court, and Heart the City 7 Hills Church – Painting and Mulching projects.
    - b) In Process: Richardson Road playground and dugouts.
  - b) The Commission thanked the Parks Staff for a job well done. It was suggested that we advertise these accomplishments in the news media. Maybe have a Grand Reopening at Doe Run or contact local media staff to visit.
